

Promotional Rules: NASCAR® Powerball – The Chase™ to \$1 Million

Promotion Type: Ticket for entry

Promotion Detail: All registered Players Club members may enter the NASCAR® Powerball – The Chase™ to \$1 Million Giveaway by scanning eligible Powerball tickets in the Oklahoma Lottery app. Each individual Powerball play submitted and scanned equals one (1) entry. Tickets with multiple plays will receive one (1) entry per play. For example, a ticket with five (5) plays will receive five (5) entries.

Eligibility requirements:

- All prize winners must be 18 years or older and registered with the Oklahoma Lottery app

Entry Submission Method:

Once logged into your Players Club account, select the Ticket Checker tab in the app. Scan a Powerball ticket purchased between May 1 and May 31 to be automatically entered into the applicable promotion.

Drawing Information:

The drawing will be conducted at the Oklahoma Lottery Commission (OLC) headquarters.

All entries will be digitized and assigned a unique number. A computer-based automated drawing system will be used. The drawing will be conducted in the following order: One (1) entry will be drawn for the 1st Place prize. The selected entrant will be subject to the OLC validation process. If the winner does not complete the claims process, an alternate will be drawn. Upon successful validation and acceptance of the 1st Place prize, one (1) additional entry will be drawn for the 2nd Place prize. The selected entrant will be subject to the OLC validation process. Additional entries may be drawn as alternates in the event a selected winner is deemed ineligible or fails to

complete the claims process. All winners must successfully complete the OLC Claims process within three (3) business days of notification or the prize will be forfeited and awarded to an alternate.

Promotion Information:

NASCAR® has partnered with Powerball® to offer players a chance to participate in NASCAR® Powerball – The Chase™ to \$1 Million. One (1) Oklahoma player will be selected as the state's official semi-finalist and will advance to the national promotion. All participating lotteries will submit one semi-finalist to form a national pool. Semi-finalists will compete through a series of drawings for a chance to win the \$1,000,000 grand prize. The NASCAR® travel prize awarded by the Oklahoma Lottery is separate from the national promotion.

National Promotion Disclaimer:

The 1st Place winner will be designated as Oklahoma's official semi-finalist in the NASCAR® Powerball – The Chase™ to \$1 Million national promotion. The national promotion, including the \$1,000,000 grand prize drawing and any associated travel or event participation, is administered separately by the Multi-State Lottery Association (MUSL) and its partners.

Participation in the national promotion is subject to additional terms and conditions provided by MUSL.

National Finalist Requirements:

The 1st Place winner must comply with all national promotion requirements, which may include:

- Completion of required forms and documentation
- Background checks
- Execution of liability and publicity releases
- Compliance with all travel, event, and production requirements

Failure to comply may result in disqualification from the national promotion.

Proxy Designation (National Promotion):

If the 1st Place winner is unable to participate in required national promotion activities, they may designate a proxy in accordance with national promotion rules and deadlines.

The winner will remain eligible for the \$1,000,000 grand prize drawing.

Oklahoma Lottery General Rules and Procedures:

1. In order to be eligible to enter and win a promotional prize, players must download and register for the Oklahoma Lottery app to their iOS or Android device. ALL registration fields must be accurately complete (first and last name, email, birth date, phone number, address, city, zip, and password) or players will be automatically disqualified. Players must be registered, have confirmed their email address, and verified their account to enter for and/or win a prize on the app. Players must agree to the terms of service and privacy policy of the app. Once their account is verified, a player can log in to their account to participate in promotions.
2. All prize winners must be 18 years or older to register, enter for, and/or win a prize on the app. All winners will be required to provide a government issued photo ID. Winners will be notified via email or phone of their winning status using the contact information provided on their user account. After initial contact, winner must complete the OLC validation process within three (3) days or the winner will automatically forfeit the prize. If a winner is not able to be reached, the prize will be forfeited. Final awarding of prize will take place after all validation processes have been completed. Any other variation to the communicated deadline must have an approval by the OLC Director of Marketing and Product Development.
3. Winner(s) may pick up all prizes at the Oklahoma Lottery Winner Center. Winners may receive cash prizes by cash, check via mail, or direct deposit. Winner(s) must provide a government issued photo I.D. via email or in person as proof of age to claim their prize. Winner(s) may forfeit the prize. In doing so, that prize will be awarded to an alternate winner. Prizes are non-transferable and not redeemable for cash. For the 2nd Place trip prize only, the winner may bring one (1) guest to participate in the trip. No other substitution or transfer is permitted.
4. By submitting an entry, each player authorizes the OLC to release prize winner information through various media sources. Winners' names and pictures may be posted on the OLC website (www.lottery.ok.gov), digital screens at

retailers and outdoor billboards throughout the state and can be used at authorized OLC retailers and on social media platforms. The winner hereby consents to the reasonable use by the OLC of the winner's photographs, voice, likeness, and/or image, contents of the entry form and the name and age of the winner without any further notice or compensation for any future promotional activity. Winner(s) that claim their prize remotely or by mail will be required to submit a photo of themselves via email before prizes will be awarded.

5. The OLC reserves the right, at its sole discretion, to substitute a prize of equal or greater value if any prize cannot be awarded as described due to unavailability or for any other reason. Additional restrictions and conditions specific to any particular prize will be disclosed to winners upon prize notification.

The OLC retailers who purchase tickets within their store can participate in the promotion, however, entries or tickets left or discarded the store by purchasing customers will not be eligible for the promotion.

14. Once final transfer of a prize is complete, the winner has sole ownership of the prize and the use of the prize is at the owner's discretion.
